Recognition Order

WHEREAS in terms of Section 15(1) of the NCTE Act, 1993, TAKSHILA COLLEGE, PLOT NUMBER: 430/2/3, 430/2/2, STREET NUMBER: NH-12, VILLAGE: JHIRNIYA, POST OFFICE: PARWALIA SADAK, TEHSIL/TALUKA: HUZUR, TOWN/CITY: BHOPAL, DISTRICT: BHOPAL 462036, MADHYA PRADESH (WRCAPP1764.) had submitted an application on 30/09/2011 to the Western Regional Committee of the NCTE for grant of permission for Increase in Intake of 50 seats in the existing D.El.Ed. Course.

AND WHEREAS, the inspection of the institution was conducted on 01/05/2012.

AND WHEREAS, the visiting team report along with other documents, videograph was placed in 175th meeting of WRC held from December 6-7, 2012 and the Committee decided that LOI under clause 7 (9) of NCTE Regulation, 2009, be issued. Accordingly, letter was issued to the institution on 04/01/2013.

AND WHEREAS, the reply submitted by the institution on 28/02/2013 was placed before WRC in its 184th meeting held from May 27-29, 2013 and the Committee decided that Recognition is granted from 2014-15 keeping in view of the Supreme Court Judgment dated 13.12.2012 under WP(Civil) 276/2012. Accordingly, Recognition Order was issued to the institution on 01/07/2013.

AND WHEREAS, the institution filed Writ Petition (Civil) No. 374 of 2013 in the Hon'ble Supreme Court of India. The Hon'ble Supreme Court of India vide order dated 03/07/2013 has directed as follows:-

*We allow this writ petition in terms of our order passed in writ petition (C) No. 221 of 2013 titled M.R. Bharti College of Education v. National Council for Teacher Education & Anr. And direct that the recognition granted by the NCTE in the formal order dated 27th June/1st July, 2013 will apply for the academic sessions 2013-2014 and from 2014-2015.

We make it clear that this order has been passed in the peculiar facts and circumstances of this case and will not be treated as a precedent by the High Court to deviate from the time schedule fixed in the aforesaid judgment in Maa Vaishnodevi Mahila Mahavidyalay (supra) and as modified vide order dated 18th June 2013 in IA No. 2 in Civil Appeal No. 9078 of 2012 titled Weltech College of Education & Anr. V. State of U.P. & Ors."

AND WHEREAS, the Court order was placed before WRC in its 189th meeting held from August 29-31, 2013 and the Committee decided that "orders of the Hon'ble Supreme Court be complied with."
